### HORSES IN EUROPE

#### European Equestrian Federation's SURVEY 2015 – released on 15 October 2015

- Total Economic impact of the Equestrian sector in 10 EU Countries: **€34 billion**
- Directly registered persons in the sport in 27 countries : **1.9 million**
- Estimated total number of horses : **4.5 million**
- Every 5 horses creating one full-time employment: **900,000 jobs**

## Ongoing European Regulation

### Animal Health/Welfare

#### Proposal for a regulation on the zootechnical and genealogical conditions for the breeding, the trade in and entry into Europe of purebred breeding animals – COM (2014)0005

The proposals gathered various pieces of previous legislation and aim at providing the principles and rules governing the breeding of bovine, porcine, ovine, caprine and equine species, and those governing the official controls and other official activities carried out by the Commission and the States' (authorities in this area.

#### Impact on Horse sector

- Although the document is not changing the previous legislation, it forces countries who did not implement to harmonise and centralize the information on the breeding certificate and registration document. Moreover, as it is a regulation and not a Directive, it will be implemented without any further interpretation or delay.
- The ID document (identification, zootechnical certificate, performance test is to be discussed inside the delegated act of the Animal Health Regulation
- The important amount of breeding society makes it difficult to centralize the information and follow equines
- Derogation exists for equines to enter breeding books that are not located in the country where the horse is active.
- Cross-breeding and lineage is specified in the document

#### Agenda

**Agreement by EU institutions on a common text on 16 December 2015**

**New version is circulating and was adopted on 11/01 by the AGRI Committee of the European Parliament.**

**Final adoption by the European Parliament scheduled on 12 April 2016.**

#### Proposal for Regulation on veterinary medicines COM

The proposal includes provisions to stimulate innovation while also addressing concerns over antimicrobial resistance. More than 900 amendments have been tabled in total, addressing, the antimicrobial resistance, the prophylactic and metaphylactic use of antimicrobials, the marketing authorisation process, the environmental risk assessment as well as the clinical trials, animal testing and the protection of technical documentation.

#### Impact on the horse sector

- Ban antimicrobial treatment for better performance
- Delay to re-introduce equines in the food chain
- Register all treatments in a health document by the owner

#### Agenda

**289 amendments have been adopted on first reading by the European Parliament on 10 March 2016. A new version is now available for a discussion between Institutions.**

## Opinion Column

### Success and missed opportunity

2 recent reports from the European Parliament in which the horse industry has its place:

**New challenges and concepts for the promotion of Tourism in Europe** (rapporteur Isabella de Monte, S&D, Italy) which, among other issues, aims to highlight some of the new challenges facing the sector, including digitalisation and the rise of the sharing economy.

Report was voted at the end of October 2015 and in the chapter on Sustainable and Responsible Tourism, calls on the authorities and local operators to make a stronger effort to promote non-vehicular networks such as European bridledways, walking routes, pilgrimage routes and cycle tracks, recommends eliminating increased fares on border stretches.

Thanks to the lobbying from FITE, Equestrian Tourism Federation, the Parliament's report takes into account horses' activities.

**Enhancing innovation and economic development in future European farm management** - This AGRI own initiative report aims to address the key elements needed to enhance innovation and economic development in future European farm management.

It was voted in December and unfortunately EHN could not contact the rapporteur to explain how horse breeding activities is fully in line with practices that are innovative, and protecting our environment.
