1. Agenda and Minutes from the last Board meeting and AGM

2. Debriefing from the MEP Horse Group meeting on Health & Research

4 MEPs attending but important ones – Vicky Ford (UK, Conservatives) and Kent Johansson (SW, liberal) are both fully aware and dedicated to research issues.

MEPs involved are now contacting us for all political issues discussed in the Parliament.

EHN needs to contact and convince more MEPs in order for the group to gain credibility and visibility (other nationalities and other political groups).

All Board members must dedicate some time to the mission.

Cathy writes the Press Release.

On research issues, EHN could play its role of competence centre by gathering opinions/projects proposals of various European Research centres (INRA, Hippolia, Wageningen...).

Roly and Josh will prepare an online questionnaire/call for proposals – asking for priorities and projects.

Florence will contact the European Animal Technology Platform possibly in March to have an update of future call and planned projects.

Increase events – Cathy suggested organising meetings with EU Commission officials and asking EHN members to participate.

8. Key discussions/ developments within the EU Commission 2013

Regulations and debates with an impact on the Horse sector:

Animal Welfare – no sign of any launch of the consultation process (end 2013?) Animal Health Law – invite EU Commission at our next lunch meeting to have an update Online Gambling and financing of sport – Debate starts in EU Parliament – Ashley Fox (UK, Conservatives) is rapporteurs and other MEPs such as Yvo Bellet (EPP, BE) wishes to insist on the financial return to sport.



Sustainable Financing of Sport (Irish Presidency) – Conference in Dublin on 8 March – Bo will ask if EEF participates.

Court Case with an impact on sport sector:

Court Case in Sweden for Car Sport Federation – Ruling: non members can organise competitions, it is an economic activity so cannot be restricted unless good motives (necessary and proportionate).

Constance will contact Pascal Bioulac to obtain information on COPA Horse Group. Bo will ask Hanfried for the complete programme of Aachen Horse Show on 21 June to evaluate the possibility to invite EU officials.
