Mark Wentein welcomes all and announces some items that are not on the agenda:

Our agenda is modified because of the late withdrawal of Alain Liebert from Route d'Artagnan – However, <u>new applications</u> will be reviewed by Board members.

Feedbacks from meeting in February in EP with MEP Pascal Durand – EHN, FEEVA:

Pascal Durand has organised the meeting in support of the French Member of the Parliament Loic Dombreval missioned by the French government last Dec, to write a report on the welfare of companion animals: https://www.i-cad.fr/articles/Loic Dombreval protection animaux

Equines seem to be included in the report that must be finalised in June. End of life, euthanasia were the questions asked to Mark Wentein and Mette Uldhal.

Mette takes the occasion to ask EHN to put the "end of life issue" back on the agenda of the Association.

End 2016, EHN has taken position (position paper attached) and has linked its activities and conferences to this topic by inviting Pierre Naassens representing UECVB (EP Conference on 16/10/2018).

Life-time exclusion debate continues to be a priority of EHN. The position paper (attached) will be updated.

New trainee from mid-May to end August - Angèle Dequesne (profile attached)

Perfect situation as she is paid and socially covered by Louvain University to study public affairs messages. She is a passionate horse rider; and studies public affairs and political science in France and Belgium. She will be a great support in the preparation of EU meetings and documents. Paull Khan suggests to ask for collection and compilation of all equine welfare initiatives.

5. Prepare EU projects: next EU Research programme + Erasmus+ Sport funding

Camille Vercken from Hippolia presents possible EU projects applications:

Erasmus+ Sport

Collaborative Partnerships action offers the opportunity to organisations to develop, transfer and/or implement innovative outputs and/or engage into intensive dissemination and exploitation activities of existing and newly products or innovative ideas in different areas relating to sport.

1. Hippo Mundo project

Create a database of all Sport Horses Stud books – 72 considered inside WBFSCH + 25 outside Combine/Compile pedigree information with performances WBFSCH and FEI (owner of International performances) are opposed to the project.

- 2. Hippolia/FEI database gathering sanitary information/performances for competition and travelling purposes in the perspective of 2024 Olympics.
- 3. Horse Racing Education of professionals on Integrity/EMHF/UET

Could be a continuity to the Erasmus+ funded DIME project coordinating five vocational schools for future drivers (trotting) - the two-year project including schools in SW, NO, FR, will finish in 2020 Pascal Launey, Director of AFASEC in Graignes and EEN Director, Markus, will be contacted.

4. Create a Horse Welfare label in cooperation with many countries – invent sanction and insurance withdrawal from equine entrepreneurs in Holland if they don't apply the rules correctly – could EHN look at practices in various countries? NDL, FR, SW, FIN

HORIZON 2020 - Last call in January 2020

1. HeavyHorsePlus

Aim is to revive the breeding and rearing of heavy horses in Europe by means of. a consortium. The project includes:

- Genetics and genomics over> 30 varieties
- Research on meat quality
- Research on milk quality
- Research on work capacity

With the objective of increasing the sustainability of heavy horse farming in the EU

The call is FNR-05-2020 (https://ec.europa.eu/info/funding-tenders/opportunities/portal/screen/opportunities/topic-details/fnr-05-2020)

There are already about 15 partners in the consortium

Poland, Germany, Austria, Luxembourg, Italy, France, Spain, Slovenia, Australia (as an expert) with mainly scientists and also some other organizations (FECTU, Animal welfare).

An amount of approximately EUR 6 million will be requested.

2. INNOSUP call (Horizon 2020: INNOSUP-01 "Cluster facilitated projects for new industrial value chains" (November 2019 – Deadline 3rd April 2020).

Hippolia Cluster to federate other EU Equine clusters (FIN, SW, BE...). The objective of this call is to develop the value chain linked to innovation in the equine sector by building joint projects between the various European networks and by promoting innovative projects between our members. Budget 2.5 to 5 million euros.

HORIZON EUROPE research programme (2021)

- 3. Equine Thematic Network proposal in preparation at IFCE for January 2021 "sustainable Horse" "Horse in Society"
- Improvement of sustainable practices (exchange of best practices, dissemination of knowledge) → related to the work already done by Agata on Green Assets
- Improvement of incomes in an agricultural sector (exchange of best practices, dissemination of knowledge)

This project will insist on assets of equine animals on the development of a sustainable agriculture and on rural development.

1st stage - at the national level (IFCE): project definition and elaboration of a synthesis; partner search in France

2nd stage (in April/May) – partner search at the European level

6. Communicate with Animal Rights Association (topic added on the demand of FECTU)

Ethical perspectives mixed with modern constraints.

Global momentum at the moment on Social License

Topic on how to use the horse/Evidence based – write a position paper

Create a narrative justification on benefits for horses and humans

The objectives is to convince decision makers/politicians and the public by expressing all the values of equines in our society.

We must also prepare farmers to stand up and communicate the right way because they will treat animals the correct way.
